Guarantor hereby subordinates in favor of the Issuer Parties any right of subrogation and all other obligations of the applicant to Guarantor. If any provision of this Guaranty is held to be illegal, invalid or unenforceable it shall not affect any other provision hereof. This Guaranty shall be governed by the law of Utah. If collection hereunder is by an attorney at law, the Guarantor shall pay all costs of collection, including attorney fees of 15%. The terms and conditions of the Customer Agreement are incorporated by reference and Guarantor agrees to be bound thereby. The Guaranty shall be relied upon by the Issuer Parties in making credit decisions and is a condition of the extension of credit to the Applicant. Guarantor hereby authorizes the Issuer Parties to obtain a consumer credit report of Guarantor and to make direct inquiries of employers and businesses where Guarantor has accounts. If this Application is denied based on such information, Guarantor authorizes the Issuer Parties to report the reason for the denial to Applicant. If the Guaranteed Obligations are not paid when due, the Issuer Parties may report the Guarantor's liability for and the status of the account to credit bureaus and others who may lawfully receive such information.
